

Bosch Electrician's Apprenticeship Starter Pack Giveaway ("**Promotion**") – Terms & Conditions

1. By entering the Promotion, entrants agree to be bound by these Terms & Conditions (the "**Terms**").
2. The promoter is Robert Bosch Limited, a company incorporated in Scotland with company number SC013418, whose registered office address is c/o Bosch Rexroth, Viewfield Industrial Estate, Glenrothes, KY6 2RD, United Kingdom ("**Promoter**"). The Promoter has appointed Clear B2B Marketing & PR Limited of 9 Priory Court, Poulton, Cirencester, Gloucestershire, GL7 5JB, UK (company number 02454970) ("**Clear B2B**") to assist Promoter with managing and administering this Promotion. Therefore, Clear B2B will be performing some of the obligations stated in these Terms on behalf of the Promoter.
3. The Promotion will commence on 05.02.24 10:00 (GMT). The closing date for receipt of entries is 09.02.24 at 23:59 (GMT) ("**Closing Date**"). The Prize Draw Promotion is free to enter and no purchase is necessary.
4. The Promotion is open to electrician apprentices in Great Britain aged 16 or over who have an Instagram account except for employees of the Promoter, or any other company within the Bosch group of companies (including BSH Home Appliances Limited), and their immediate family members, Bosch's agents, authorised retailers or their employees, or any person professionally associated with this activity (or members of their family or household) may not participate in the Promotion ("**Eligible Participant**"). Entrants must currently be enrolled as an electrician apprentice. Proof of apprenticeship status is required and can be provided through the submission of valid apprenticeship photographic identification once the prize winner has been contacted. Identification including, but not limited to, college or sixth form photographic I.D., UNIDAYS I.D., Student Beans I.D. or NUS UK I.D.
