

## GWX18V-11PS Prize Draw (the “Promotion”) - Terms and Conditions

1. By entering the Promotion, entrants agree to be bound by these terms and conditions (the “Terms”).
2. The promoter is Robert Bosch Limited, a company incorporated in Scotland with company number SC013418, whose registered office address is C/O Bosch Rexroth, Viewfield Industrial Estate, Glenrothes, KY6 2RD, United Kingdom (“Promoter”). Clear B2B Marketing & PR Limited, a company registered in England with company number 02454970 whose registered office is at Festival House, Jessop Avenue, Cheltenham GL50 3SH (“Clear B2B”) have been appointed to assist the Promoter with managing and administering this Promotion. Therefore, Clear B2B will be performing some of the obligations stated in these Terms on behalf of the Promoter.
3. The Promotion will commence on 27 April 2026 at 17:00 (BST). The closing date for receipt of Entries is 12 May 2026 at 23:59 (BST) (“Closing Date”). The Promotion is free to enter and no purchase is necessary.
4. The Promotion is open to individuals aged 18 or over, resident in Great Britain and Northern Ireland (“Eligible Participant”). Employees of the Promoter, or of any other company within the Bosch group of companies (including BSH Home Appliances Limited), and their immediate family members, Bosch’s agents or their employees, or any person professionally associated with this Promotion (or members of their family or household) may not participate in the Promotion.
5. The Promoter assumes that by entering the Promotion (and you warrant that) you are aged 18 or over. The Promoter reserves the right to verify the eligibility of all Eligible Participants and disqualify any Eligible Participant that it has reasonable grounds to believe has breached any of the Terms, including, but not limited to, falsifying any information submitted to or requested by the Promoter.
20. The Promoter reserves the right to amend or terminate the Promotion at any time without notice. However, the Promoter will use its reasonable endeavours to minimise the effect of such amendment or termination to avoid disappointment. Any termination or amendment to the Promotion will be communicated to you in the same way as the Promotion was communicated.
21. The Promoter excludes all liability for taxes relating to the Prize Bundle and any tax liability arising from the provision of the Prize Bundle will be the sole responsibility of the recipient of the Prize Bundle.

## **Annex 1 – Promotion – Data Protection Notice**

### **1. Data Protection Notice**

This data protection notice covers the processing of your personal data in relation to Robert Bosch Limited (hereinafter “**Bosch**” or “**We**” or “**Us**”) promotion (hereinafter “**Promotion**”).

### **2. Bosch respects your privacy**

The protection of your privacy throughout the course of processing personal data as well as the security of all business data are important concerns to us. We process personal data confidentially and only in accordance with statutory regulations.

Data protection and information security are included in our corporate policy.

### **3. Controller**

Robert Bosch Limited with its registered office at C/O Bosch Rexroth, Viewfield Industrial Estate, Glenrothes, KY6 2RD, is a controller responsible for the processing of your data.

### **4. Collection, processing and usage of personal data**

#### **4.1 Processed categories of data**

The following categories of data are processed:

- Communication data (e.g. name, telephone, e-mail, address)
- Miscellaneous: any personal data you provide in the entry to the Promotion (such as TikTok username and picture, identifiable biometric data).

#### **4.2 Principles**

Personal data consists of all information related to an identified or identifiable natural person, this includes, e.g. names, addresses, email addresses, contractual master data, contract accounting and payment data, which is an expression of a person’s identity.

We collect, process and use personal data only when there is either a statutory legal basis to do so or if you have given your consent to the processing or use of personal data concerning this matter, e.g. by means of registration.

#### **4.3 Processing purposes and legal basis**

We, as well as the service providers commissioned by us, process your personal data for the following processing purposes:

4.3.1. Receiving entries for the Promotion, conducting the Promotion and notification and delivery of prizes from the Promotion as outlined in our Terms.

(Legal basis: fulfilment of the contractual obligations as described in the Promotion Terms as well as our legitimate business interests in connection with the Promotion and supply of the Prize Bundle.)

#### 4.4 Children

The Promotion is not meant for children under 18 years of age.

#### 4.5 Data transfer to other controllers

Principally, your personal data is forwarded to other controllers only if required for the fulfilment of a contractual obligation, or if we ourselves, or a third party, have a legitimate interest in the data transfer, or if you have given your consent. Particulars on the legal basis and the recipients or categories of recipients can be found in the Section 4.3 Processing purposes and legal basis. Third parties may also be other companies in the Bosch group.

For announcement of your parcels, we may transfer your email address within the scope of the fulfilment of the contractual obligations to the following:

[FEDEX EXPRESS UK LIMITED, Express House, Holly Lane, Atherstone, CV9 2RY (or other companies within FEDEX Group). This company may process data as a data controller. ]

Additionally, data may be transferred to other controllers when we are obliged to do so due to statutory regulations or enforceable administrative or judicial orders.

#### 4.6 Service providers (general)

We may involve external service providers with tasks such as administration and organisation of the Promotion, procurement, parcel collection and delivery. We have chosen those service providers carefully and monitor them on a regular basis, especially regarding their diligent handling of and protection of the data that they store. We only transmit your data to external service providers where necessary to fulfil a contract with you, where we or the recipient has a legitimate interest in the disclosure of your data, or where you have given your consent to that transmission. We involve external service providers including [Clear B2B] with tasks such as contract management (including validating Entries and selecting random Winner(s) for the Promotion. All service providers are obliged to maintain confidentiality and to comply with the statutory provisions. Service providers may also be other Bosch group companies.

#### 4.7 Transfer to recipients outside the UK and EEA

We might transfer personal data to recipients located outside the UK and EEA into so-called third countries. In such cases, prior to the transfer we ensure that either the data recipient provides an appropriate level of data protection or that you have consented to the transfer.

You are entitled to receive an overview of third country recipients and a copy of the specifically agreed provisions securing an appropriate level of data protection. For this purpose, please use the contact details in section 3 of this Annex 1.

#### 4.7 Duration of storage, retention periods

Principally, we store your data for as long as it is necessary for us to fulfil the contract or for as long as we have a legitimate interest in storing the data. In all other cases we delete your personal data

with the exception of data we are obliged to store for the fulfilment of legal obligations (e.g. due to retention periods under the tax and commercial codes we are obliged to have documents such as contracts and invoices available for a certain period of time). Your information will be deleted once it is no longer required to run the Promotion or once it is no longer necessary to complete any follow-ups with the Winner.

## **5. Security**

Our employees and the companies providing services on our behalf, are obliged to confidentiality and to compliance with the applicable data protection laws. We take all necessary technical and organizational measures to ensure an appropriate level of security and to protect your data that are administrated by us especially from the risks of unintended or unlawful destruction, manipulation, loss, change or unauthorized disclosure or unauthorized access. Our security measures are, pursuant to technological progress, constantly being improved.

## **6. User rights**

To enforce your rights, please use the details provided in section 3 of this Annex 1. In doing so, please ensure that an unambiguous identification of your person is possible.

### Right to information and access

You have the right to obtain confirmation from us about whether or not your personal data is being processed, and, if this is the case, access to your personal data.

### Right to correction and deletion

You have the right to obtain the rectification of inaccurate personal data. As far as statutory requirements are fulfilled, you have the right to obtain the completion or deletion of your data.

This does not apply to data which is necessary for billing or accounting purposes or which is subject to a statutory retention period. If access to such data is not required, however, its processing is restricted (see the following).

### Restriction of processing

As far as statutory requirements are fulfilled you have the right to demand for restriction of the processing of your data.

### Data portability

As far as statutory requirements are fulfilled you may request to receive data that you have provided to us in a structured, commonly used and machine-readable format or – if technically feasible – that we transfer those data to a third party.

### Object to direct marketing

Additionally, you may object to the processing of your personal data for direct marketing purposes at any time. Please take into account that due to the organizational reasons, there might be an overlap between your objection and the use of your data within the scope of a campaign that is already running.

### Objection to data processing based on the legal basis of “legitimate interest”

In addition, you have the right to object to the processing of your personal data at any time, insofar as this is based on legitimate interest. We will then terminate the processing of your data unless we demonstrate compelling legitimate grounds according to legal requirements which override your rights.

#### Withdrawal of your consent

In case you consented to the processing of your data, you have the right to revoke this consent at any time with effect for the future. The lawfulness of data processing prior to your withdrawal remains unchanged.

#### **7. Right to lodge complaint with supervisory authority**

You have the right to lodge a complaint with a supervisory authority. You can appeal to the supervisory authority which is responsible for your place of residence or your state of residency or to the supervisory authority responsible for us.
