# **Bosch Professional Power Tools & Measuring Tools Cash Back Offer Terms & Conditions**

- 1) The specific rules set out in these Terms & Conditions apply to this Promotion. By participating in this offer, entrants agree to be bound by these Terms & Conditions.
- 2) The promoter is Robert Bosch Limited, a company incorporated in England and Wales with company number SC013418, whose registered office address is at C/O Bosch Rexroth, Viewfield Industrial Estate, Glenrothes, KY6 2RD United Kingdom ("Promoter").
- 3) The Promotion is administered by Carousel Marketing Limited of PO Box Newhall Court, George Street, Birmingham B3 1QA ("Administrator"). Any queries related to the Promotion should be sent to the Administrator.
- 4) Employees of the Promoter, or any other company within the Bosch group of companies (including BSH Home Appliances Limited), and their immediate family members, Bosch's agents, authorised retailers or their employees, or any person professionally associated with this activity (or members of their family or household) may not participate in the Promotion, unless otherwise agreed with the Promoter.

## To be eligible to participate in the Promotion

- 5) The Promotion will commence on 01/01/2017 and close on 31.12.2018 ("**Promotional Period**").
- 6) The Promotion is open to consumers of Bosch 'Blue' professional power tools and measuring tools resident in the United Kingdom. ("Eligible Participant").
- 7) You will not be eligible to enter the Promotion if you are a dealer, supplier or merchant.
- 8) The Promoter assumes that by using the website and/or entering the Promotion (and you warrant that) you are aged 18 or over.
- 9) If you are entering the Promotion as an employee of an organisation then you have an obligation to (i) inform your employer about the Promotion, and (ii) obtain the permission of your employer to enter the Promotion.

### Bosch 'Blue' Professional Power Tool & Measuring Tool

- 10) Eligible Participants will qualify for the Cashback Offer providing they satisfy the following criteria:
  - a) the Eligible Participant owns a Bosch Professional Power Tool or measuring tool ("**Tool**") that has developed a fault;
  - b) the fault has developed in the Tool outside of the warranty period, or the fault is not of a type covered by warranty;
  - c) the Eligible Participant has notified the Promoter of the fault via <a href="https://www.bosch-professional.com/gb/en/service/after-sales-service-/online-repair-service/online-repair-service.html">https://www.bosch-professional.com/gb/en/service/after-sales-service-/online-repair-service/online-repair-service.html</a> or the contact centre on 0344 736 0109 ("Repair Request Process") and has been provided with a quote for the repair of the Tool or received confirmation that it would be uneconomic to repair to Tool; and
  - d) the Eligible Participant has opted to purchase a new Tool rather than electing for repair has requested and received (or a merchant has received on their behalf) a reference code via email from the Promoter to participate in the cashback offer ("Reference Code").

# ("Entry Requirements")

- 11) A Tool will be a "Qualifying Product" if it fulfils the below requirements;
  - a) The Promotion only applies to Tools purchased by an Eligible Participant within the United Kingdom within 14 days of receipt of the Reference Code Tools that are purchased from alternative markets shall not be Qualifying Products.
  - b) This Promotion is not available on the purchase of any second hand or graded stock.
  - c) The Promotion is subject to the continuous ownership of the Tool. The Promoter reserves the right to withdraw any claim if the Tool is returned or resold.
  - d) A Tool will not be a Qualifying Product if it is purchased outside of the Promotional Period.

#### **Cashback Offer**

- 12) The Cashback award shall be an amount equal to 10% of the price of the Qualifying Product (excluding VAT) and subject to a maximum claim of £50.00 ("Cashback Offer"). Please note only the Administrator will be shall hold data on the details of the purchase price of the Qualifying Products. Individual purchase prices will not be shared with the Promoter.
- 13) The Cashback Offer is non-transferable and there is no alternative. The Promoter reserves the right to substitute awards of equal or greater value at any time.

#### How to claim the Cashback Offer

- 14) To claim the Cashback Offer for a Qualifying Product the Eligible Participant must:
  - (i) purchase the Qualifying Product within 14 days of receiving the Reference Code ("Closing Date")

    - c. a copy of the invoice for the Qualifying Product; and
    - d. their bank details into which the Cashback Offer should be paid.
- 15) All other proof of purchase will not be accepted, including, but not limited to, illegible invoices, delivery dockets, receipts (part payment or otherwise), delivery notes, confirmation of orders or other handwritten documents.
