

Bosch Professional Garden Tools Quiz Prize Draw 2026 (the “**Promotion**”) - Terms and Conditions

If any selected Winner is disqualified, fails to claim their Prize, or forfeits the Prize for any reason under these Terms, no alternative Winners will be selected, and the respective Prize will remain unawarded.

1. Subject of the Terms and Conditions, Organiser

- 1.1. These Terms govern participation in the Prize Draw.
- 1.2. The organizer of the Prize Draw is Robert Bosch Power Tools GmbH, Max-Lang-Straße 40-46, 70771 Leinfelden-Echterdingen (“**Organiser**”).
- 1.3. Robert Bosch Limited with company number SCO13418 and registered office: c/o Bosch Rexroth, Viewfield Industrial Estate, Glenrothes KY6 2RD is commissioned by the Organiser to assist in conducting the promotion (“**Promoter**”).
- 1.4. Playable ApS, a company registered in Denmark with company CVR number 36986476 whose registered office is at Tueager 1, 8200 Aarhus, Denmark (“**Playable**”), is commissioned by the Organiser to host the online promotional quiz platform and assist in executing the Prize Draw on behalf of the Organiser.
- 1.5. By participating in the Prize Draw, these Terms are accepted. Participants can access and print the currently valid Terms at any time under the “Bosch Professional Garden Tools Quiz Prize Draw 2026” Prize Draw (<https://bosch-power-tools-centralized.campaign.playable.com/pro-garden-uk>)
- 1.6. This Prize Draw is in no way affiliated with, sponsored by, endorsed by, or administered by Facebook or Instagram. Facebook and/or Instagram are not the contact person for this Prize Draw. The recipient of the data and information provided by the participant is Robert Bosch Power Tools GmbH. 2. Eligibility, Participation Requirements, Participation Period

- 2.1. The Prize Draw is open to individuals aged 18 or over, resident in the United Kingdom, Northern Ireland, the Republic of Ireland, the Channel Islands, and the Isle of Man.
- 2.2. To enter the Promotion, a participant must, during the Participation Period:
 - 2.2.1 Visit the official Promotion page hosted on the Playable platform;
 - 2.2.2 Complete the online promotional quiz;
 - 2.2.3 Achieve a score of at least 7 out of 10 on the quiz to qualify; and
 - 2.2.4 Upon successfully achieving a qualifying score of 7 out of 10, fill in and submit the official entry form with their personal details (including their email address) and accept these Terms.
(Altogether an “**Entry**”).
- 2.3. Participants may enter the Promotion as many times as they wish during the Participation Period. To enter multiple times, each time the participant must successfully complete the quiz and achieve a score of 7 out of 10, and then submit or re-submit their details each time.
- 2.4. A maximum of one (1) Prize (as defined above) per participant is permitted throughout the entire Promotion. The unique identifying point that determines a single “person” eligible to win is their email address.
- 2.5. It is not necessary to purchase Bosch products or services to participate in the Prize Draw. The chances of winning do not increase through the purchase of products or services.
- 2.6. Any Entry that does not contain the information required above or comply with all requirements will be deemed an invalid Entry and will not be entered into the Promotion. The Promoter accepts no responsibility for Entries not successfully or fully completed due to any reason, including technical faults.
- 2.7. Excluded from participation are (i) employees of the Organiser and its affiliated companies who are directly involved in the conception, execution, or processing of the Prize Draw, and (ii) persons who violate these Terms.
- 2.8. There is no entitlement to participate in the Prize Draw. Participation with false identities or the identities of third parties is not permitted. Automated participation (e.g., via entry and registration services) is not permitted. Fraud through website hacking, use of automation software, exploitation of software bugs, etc., will lead to the participant's disqualification.
- 2.9. The participant bears the costs associated with the online connection when participating in the Prize Draw.

3. Prize, Winner Selection

- 3.1. A “**Winner**” (referred to individually as a “**Winner**” and collectively as the “**Winners**”) is defined as an participant who has:
 - 3.1.1 Completed a valid Entry;
 - 3.1.2 Been selected at random during the official Prize Draw; and
 - 3.1.3 Been successfully verified as meeting all eligibility criteria set out in these Terms.
- 3.2. There will be one (1) draw of Winners that will take place within seven (7) days of the Promotion closing on 31 August 2026.

- 3.3. The draw will be carried out at random by Playable (acting as a data processor on behalf of the Organiser) from the total pool of all valid, qualifying Entries.
- 3.4. A total of twenty (20) Winners will be drawn. If any selected Winner is disqualified, fails to claim their Prize, or forfeits the Prize for any reason under these Terms, no alternative Winners will be selected, and the respective Prize will remain unawarded.
- 3.5. The Prizes cannot be exchanged, and no cash or other alternative is available.
- 3.6. The Prizes must not be auctioned or resold. The Promoter reserves the right to refuse to accept further Entries under this Promotion or any other promotion if they become aware of the reselling or auctioning of a Prize.
- 3.7. The twenty (20) Winners will be contacted by email by the Organiser within seven (7) days of the draw. The email will ask the Winners to accept the Prize and confirm their correct postal delivery address.
- 3.8. Winners have twenty-eight (28) days from the date the notification email is sent to accept their Prize and provide their postal delivery address. If a Winner fails to respond and accept within this 28-day window, they will forfeit their Prize. Under no circumstances will alternative winners be selected.
- 3.9. Once a Winner accepts their Prize and confirms their delivery details, these details (including the Winner's email address) will be securely transferred to the Promoter. The Promoter will be responsible for distributing and shipping the Prizes and contacting the Winner directly in case of any further queries.
- 3.10. Prizes will be dispatched and delivered to the Winners at the Promoter's cost within twenty-eight (28) days of the Winner accepting the Prize and providing their valid postal address. The Promoter cannot accept responsibility for delayed, lost, or incorrectly submitted delivery details.
- 3.11. In all matters relating to the Promotion, the decision of the Promoter shall be final and no correspondence or discussion shall be entered into.
- 3.12. At all times throughout the Promotion, participants must deal with the Promoter in the utmost good faith in every respect. The Promoter reserves the right to verify the eligibility of all participants and disqualify any participant that they have reasonable grounds to believe has breached any of the Terms, including, but not limited to, falsifying any information submitted to or requested by the Promoter, or using automated systems, software bugs, or manipulation to gain an unfair advantage.
- 3.13. The Organiser, at its own discretion, reserves the right to substitute the Prize with product(s) of equal or greater value at any time.

4. Liability

- 4.1. The Organiser is liable in accordance with statutory provisions (i) in cases of intent and gross negligence, (ii) in accordance with the provisions of the Product Liability Act, (iii) to

the extent of any guarantee assumed by the Organiser, and (iv) in cases of injury to life, body, or health.

- 4.2. In cases of negligently caused property damage and financial loss, the Organiser is liable only for breaches of a material contractual obligation, but only up to the amount of damages foreseeable and typical for this type of contract at the time of its conclusion. Material contractual obligations are those whose fulfillment is essential to the user agreement and on which the participant may rely.
- 4.3. Otherwise, liability is excluded.
- 4.4. Statutory limitations of liability that deviate from the above liability provisions in favor of the Organiser remain unaffected.
- 4.5. The foregoing limitations of liability also apply in the event of fault on the part of an agent of the Organiser, as well as to the personal liability of the Organiser's employees, representatives, and officers, and to claims for reimbursement of expenses.
- 4.6. The foregoing provisions do not entail any shift in the burden of proof to the detriment of the participant and do not affect any of the participants statutory rights and protections under local laws.

5. Premature Termination, Exclusion

- 5.1. The Organiser reserves the right to cancel or terminate the Prize Draw at any time for good cause without prior notice. Good cause exists, for example, if malfunctions, disruptions, falsifications, viruses, or similar damage occur that impair the administration, security, fairness, integrity, or conduct of the Prize Draw.
- 5.2. The Organiser reserves the right to exclude participants who, during the course of the Prize Draw, express themselves in an abusive, threatening, or immoral manner, or who violate these Terms. This applies in particular if participants use manipulation or other dishonest means. In such cases, the Prize may also be revoked and reclaimed retroactively.

6. Data Protection

- 7.1. Legal recourse is excluded.

- 7.4. The laws of the Federal Republic of Germany shall apply subject to any additional statutory rights granted under participants local laws.

(1) Data Controller, Contact Information

(2) Processing of Personal Data

The following personal data of participants will be processed as part of this promotion:

- Email Address
- In case of winning: Name, First Name, Address

(3) Purpose of Processing

This data is collected, processed, and used for the following purpose: Conducting the Prize Draw and sending the prizes.

(4) Legal Basis

The legal basis for this processing is Article 6(1)(b) GDPR. All references to GDPR in this data privacy notice include both EU GDPR and UK GDPR.

(5) Necessity of Providing Data

The provision of personal data is necessary for participation in the prize draw. Failure to provide this data may result in non-participation.

(6) Data Sharing

The data of the participants will only be processed by Bosch and, where applicable, carefully selected and contractually obligated service providers for the purpose of conducting the promotion and sending the prizes. These service providers include, for example, Playable ApS and Robert Bosch Limited. For the delivery of prizes, we will transfer your name and address to the relevant transport company. Please note that by liking or commenting on platforms of the Meta Group (e.g., Facebook, Instagram), the respective platform operator will gain access to your data. The platform operator is responsible for data protection in this regard. We have no influence on which recipients Facebook or Instagram transfer your data to. The data recipients may also be located in third countries, which may have a lower level of data protection than the EU or UK and where data subject rights do not exist or cannot be exercised. The Meta Group's privacy policy applies to data processing by the Meta Group. Meta is in no way affiliated with this promotion. Bosch is solely responsible for data processing within the scope of this promotion. Furthermore, data may be transferred to other recipients if we are legally

obligated to do so or if required by an enforceable official or court order. The legal basis for this data transfer is Article 6(1)(c) GDPR.

(7) Data Retention Period

Participants' data will be deleted 90 days after the product is sent, unless a legal obligation prevents deletion.

(9) Data Subject Rights

You have the right to request information from the controller regarding your personal data, as well as the right to rectification of inaccurate data or erasure, provided one of the grounds listed in Article 17 GDPR applies, e.g., if the data is no longer necessary for the purposes for which it was collected. You also have the right to restriction of processing if one of the conditions listed in Article 18 GDPR applies, and, in the cases specified in Article 20 GDPR, the right to data portability.

(10) Right to lodge a complaint with a supervisory authority

You have the right to lodge a complaint with a data protection supervisory authority. You can contact the data protection supervisory authority responsible for your place of residence or your federal state, or the data protection supervisory authority responsible for us. The data protection supervisory authority responsible for us is the State Commissioner for Data Protection and Freedom of Information of Baden-Württemberg.
